

Amendment of The National Drug Law

(No.22/2014)

The 2<sup>nd</sup> of Tanguu lasen , 1375.

(1<sup>st</sup> April, **2014** )

Union Parliament hereby enacts the following law;

1. This Law shall be called amendment of The National Drug Law.
2. National Drug Law's para 4 shall be substituted as follows;
4. The Union Government shall form the Myanmar Food and Drug Board of Authority consisting of the following persons:-

3. In section 18 & 19 subpara(a) of the National Drug Law, punishment fine from a minimum of kyats 5000 to Maximum 50000 kyats shall be substituted by a minimum of kyats 50000 to maximum of kyats 500000 respectively.

4. In section 19 subpara(b) of the National Drug Law, punishment fine from a minimum of kyats 1000 to Maximum 10000 kyats shall be substituted by a minimum of kyats 10000 to maximum of kyats 50000 respectively.

5. In section 20 of the National Drug Law, punishment fine from a minimum of kyats 500 to Maximum 5000 kyats shall be substituted by a minimum of kyats 5000 to maximum of kyats 50000 respectively.

6. Section 32 of the National Drug Law shall be substituted as follows;
32. For the purpose of Implementation of National Drug Law-
- (a) The Ministry of Health shall have to release regulation, rules and procedures as if necessary, with the approval of the Union Government;
  - (b) The Ministry of Health, the Myanmar Food and Drug Board of Authority shall have to release the orders and directives as if necessary.
